
**ORDER APPROVING SETTLEMENT WITH MARQUIS JET PARTNERS**

This case came before the Court for hearing on June 15, 2011 of the of Receiver's Motion to Approve Settlement with Marquis Jet Partners (the "**Motion**"). Having reviewed the Motion, heard argument, and being otherwise fully advised in the premises, the Court finds that the resolution of the claim against Marquis Jet Partners, Inc. as set forth in the settlement agreement is in the best interest of the Receivership Estate. It is, therefore,

ORDERED and ADJUDGED that the Motion is granted. The Court specifically approves the written settlement agreement attached to the Motion entered into between the Receiver and Marquis Jet Partners, Inc. in all respects. It is further,

ORDERED and ADJUDGED that Marquis Jet Partners, Inc. must pay the Receiver the amount of one hundred and ninety-five thousand and no/100ths dollars (\$195,000.00) within five (5) days of the entry of this Order.
