**AGREED ORDER AUTHORIZING  
SALE OF LEXUS, BOAT, JET SKIS AND TRAILER**

This case came on for consideration of Receiver, Michael E. Moecker's ("**Receiver**") Motion for Approval of Vehicles and Watercraft (the "**Motion**"). On April 13, 2011, Jon J. Hammill ("**Hammill**") filed an objection to the Motion. The Court having been advised that Hammill and the Receiver have reached an agreement as to the sale of the vehicles and watercraft, the Court finds that the Motion should be granted as set forth herein. The Court finds that the agreement is in the best interest of the Receivership Estate and is necessary for the adequate protection of the rights of the parties. The Court further finds that the manner of sale is reasonable. Accordingly, it is,

ORDERED and ADJUDGED that the Motion is granted in part. The Receiver is authorized to employ Cliff Shuler Auctioneers, 422 Julia Street, Titusville, Florida, to sell the 2009 single axle galvanized personal watercraft trailer, the 2006 Lexus GS 300, the 2006 26ft Edgewater Power Boat equipped with two 2009 Yamaha YZ250F outboard motors, and the two 2001 10 ft. Yamahas described in the Motion for a commission of 10% of the sales price. The


Receiver shall provide Hammill notice of the date, time and location of the auction and provide an accounting to Hammill for the net amount recovered from the auction. The proceeds from the auction shall be deposited in the Receivership's account. It is further,

ORDERED and ADJUDGED that the Receiver is authorized to pay off the balance owed on the loan from Grow Financial Federal Credit Union for the 2004 Porsche 911 Turbo Cabriolet (the "Porsche"). The Porsche will not be sold until December 1, 2011 or at the conclusion of the main action, whichever comes first. The Receiver agrees to allow Hammill to purchase said Porsche upon approval from the Court and at a price not to exceed the original purchase price paid by Hammill prior to the institution of this action.
