**ORDER OVERRULING JON J. HAMMILL'S OBJECTION TO REQUEST FOR  
PRODUCTION OF DOCUMENTS FROM NICK P. COLA, CPA, P.A.**

This case came before the Court for hearing on July 16, 2010 upon the Defendant, Jon J. Hammill's ("**Hammill**") Objection to Request for Production of Documents from Nick P. Cola, CPA, P.A. (the "**Objection**"). The Court having heard argument and being otherwise fully advised in the premises, the Court finds that the Objection should be overruled with respect to the production by Nick P. Cola CPA, P.A. (the "**CPA**"), of non-privileged financial information in its possession including tax filings, financial statements, and other records of assets and liabilities of Hammill and Jon J. Hammill, P.A. Accordingly, it is ORDERED and ADJUDGED that Nick P. Cola, CPA, P.A., is hereby ordered to produce to the Receiver all tax filings made by or for Hammill and Jon J. Hammill P.A., and all financial statements and records of the assets and liabilities of Hammill and Jon J. Hammill, P.A. prepared by the CPA or provided to the CPA by Hammill or Jon J. Hammill, P.A. within five (5) days of the date of this order.
